The Adoption by the Judges of the Bankruptcy Court of the Interim Bankruptcy Rules by the Committee on Rules of Practice and Procedure of the Judicial Conference of the United States.

A duly constituted meeting of the United States District Judges for this District having been held on October 11, 1979, and it there having been concluded that the suggested Interim Bankruptcy Rules of the Committee on Rules of Practice and Procedure of the Judicial Conference of the United States be adopted as Local Rules of the Bankruptcy Court for this District to meet substantive and procedural changes mandated by the Bankruptcy Reform Legislation enacted November 6, 1978, P.L. 95-598, 92 Stat. 2549, and be promulgated by the Bankruptcy Judges of this District, and thereafter amended by such Judges as the need arises until such time as the promulgation of these and other Rules by the Supreme Court and Congress under the authority of 28 U.S.C. §2075, as amended by Section 247 of Title II of the 1978 Bankruptcy Reform Legislation,

NOW, it is

ORDERED that the Bankruptcy Judges of this District be and they hereby are empowered to establish as

Local Rules governing the substance and procedure of all cases commenced under the 1978 Bankruptcy Reform Act from October 1, 1979 and all civil proceedings arising under such cases or related to such cases the suggested Interim Bankruptcy Rules of the Committee on Rules of Practice and Procedure of the Judicial Conference of the United States, and it is further

ORDERED that the Bankruptcy Judges of this District shall have the authority to enact further Local Rules incident to cases filed under the 1978 Bankruptcy Reform Legislation and to civil proceedings arising in or related to such cases, and to modify such rules as the need for change presents itself, and it is further

ORDERED that the Clerk of the United States District Court for this District and the Clerk of the Bankruptcy Court for this District cause this order to be spread upon the records of both courts and the Clerk of the Bankruptcy Court shall forward certified copies to the Advisory Committee on Bankruptcy Rules of the Judicial Conference of the United States, and to the Chief of the Bankruptcy Division of the Administrative Office of the United States Courts, and it is further

ORDERED that upon the adoption of the suggested and other Interim Bankruptcy Rules, notice of such adoption be published in suitable form, approved by the Bankruptcy Judges of this District, in the New York Law Journal and in the Daily News Record.
