WHEREAS, the Board of Judges revised the Schedules pursuant to General Orders 284, 291 and 425, and has determined to add Schedule C to be used by applicants seeking payment of professional fees and reimbursements of expenses in cases filed under chapter 13; it is hereby

ORDERED, that [Schedule A](#) (Current Interim Fee Period) and [Schedule B](#) (Final Fee Application Totals) shall be used by applicants seeking payment of professional fees and reimbursement of expenses in all cases other than cases filed under chapter 13; and it is further

ORDERED, that [Schedule C](#) shall be used by applicants seeking payment of professional fees and reimbursement of expenses in all cases filed under chapter 13; and it is further

ORDERED, that the [form order](#), originally adopted by General Order 284 and adopted again by this General Order, shall continue to be used by applicants seeking payment of professional fees and reimbursement of expenses; and it is further

ORDERED, that newly adopted Schedule C, referred to above, shall be used in conjunction with chapter 13 fee applications filed with the Court after fourteen (14) days of the signing of this General Order.
