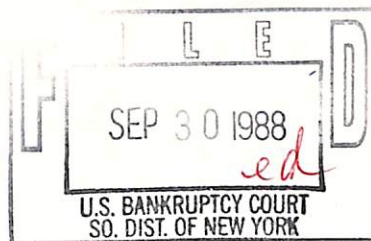


ORDERED, that Manufacturers Hanover Trust Company at the City Hall Branch is directed to change the name on the accounts listed on the annexed schedule to read as follows:
