ORDER

the Amendment of Bankruptcy Rule 16(b)(i) of
the United States District Court for the
Southern District of New York.

This Court, upon its own motion, does hereby
ORDER that the Bankruptcy Rule 16(b)(i), insofar as the same
is applicable to the Southern District of New York, is hereby amended,
effective at the beginning of business on date of this order
to read as follows:

- (b) - ORDERS ON RECOMMENDATIONS ON ALLOWANCES
- (i) - ORDERS AND RECOMMENDATIONS - SOUTHERN DISTRICT

In cases of which he is in charge, the referee shall examine
all accounts of receivers and trustees, approve or disapprove such
accounts, and, if proper, in accordance with this Rule, discharge the
receivers and trustees. The referee shall also fix compensation and
the amount thereof, in accordance with these rules and the Bankruptcy
Act, to accountants, appraisers, assignees, attorneys for assignees,
attorneys for debtors, attorneys for the petitioning creditors,
attorneys for bankrupts, attorneys for receivers and attorneys for
trustees in those estates where the total compensation fixed is, in
the aggregate of all applications for allowances, \$10,000. or less,
exclusive of commissions of trustees and receivers determined by the
schedules prescribed by Section 48 of the Bankruptcy Act. Provided,
however, that in those cases where the total compensation is, in the
aggregate of all applications for allowances, more than \$10,000.,
exclusive of commissions of trustees and receivers determined by the

schedules prescribed by Section 48 of the Bankruptcy Act, the referee shall make recommendations to the Court as to such compensation and the amounts thereof, in accordance with this Rule 16(b)(i) and Rule 16(c). Where an appraiser requests \$100 or less as compensation, the referee shall fix the value of such services and order the same as fixed to be paid.
