Mr. Kleinberg accepted the appointment on a pro bono basis and diligently worked on the matter for over a year. Notwithstanding the difficult circumstances of the case, Mr. Kleinberg was able to help facilitate a settlement.

Mr. Kleinberg received his J.D. from Hofstra University School of Law, J.D., with distinction and his A.B. from Cornell University. After law school, Mr. Kleinberg accepted a judicial
