III. General professional experience:

I am currently a mediator and arbitrator at JAMS. Prior to joining JAMS in 2010, I was Senior Vice President and Assistant General Counsel at Merrill Lynch Wealth Management. In my 25 years at Merrill Lynch, I represented the firm, its' affiliates and employees in litigation and other contentious matters relating to the broker-dealer, investment banking and institutional sales and trading businesses. Prior to joining Merrill Lynch, I was New York District Counsel to the National Association of Securities Dealers, Inc. and in the private practice of law.

IV. General pertinent experience:

I am a mediator and arbitrator affiliated with JAMS, the largest provider of mediation and arbitration services in the world, where I am a member of JAMS' Financial Services Practice Group. In connection with my JAMS association, I have undergone fifteen hours of formal mediation training, principally provided by Jay Folberg, former Dean of the University of San Francisco School of Law and co-author of *Mediation: the Roles of Advocate and Neutral*, and Jay Welsh, JAMS' General Counsel. I have also participated, both as a panelist and as an attendee, in numerous CLE programs spanning many years involving ADR, including mediation, under the auspices of the Practising Law Institute and other recognized CLE providers.

Prior to joining JAMS, I was in-house counsel at Merrill Lynch, retiring as Senior Vice President and Assistant General Counsel in 2010 after twenty-five years. During this period, I participated as both an advocate and a party representative in multiple mediations under the auspices of both state and federal courts, as well as privately. VI. Pertinent bankruptcy training:
