Pursuant to 28 U.S.C. § 1930

Payment of filing fees must be made in the form of cashier's check, money order or, in the Manhattan office, exact cash (the White Plains and Poughkeepsie offices do not accept cash). *Please do not send cash through the mail.* Additionally, parties other than debtors may pay filing fees by credit card. Attorneys may pay by an attorney's check; all checks must have a pre-printed name and address. All checks and money orders should be made payable to "Clerk, USBC, SDNY".
